

TERMS & CONDITIONS
GOLDEN DAYS PROMOTION 2023

The Golden Days Promotion (the “**Promotion**”) is subject to the following conditions:

- The Promotion will only be valid during the following periods and **only for as long as promotional stocks last in the warehouse serving the relevant Participating Market** (as defined below) during said periods:
 - **WAVE 1:** from Tuesday 18 July 2023, 10.00 AM CEST until Thursday 20 July 2023, 11.59 PM CEST; and
 - **WAVE 2:** from Tuesday 8 August 2023, 10.00 AM CEST until Thursday 10 August 2023, 11.59 PM CEST.

For the avoidance of doubt, this means that if the promotional stock of a certain SKU has been sold out in the warehouse serving a certain Participating Market, the Promotion will end in respect of the corresponding Promotional Product (as defined below) for that Participating Market. This will be the case even if there is still promotional stock of other Promotional Products available in said warehouse and the Promotion continues for those other Promotional Products in the same Participating Market, or if there is still Promotional Stock of the same SKU available in a different warehouse serving other Participating Markets and the Promotion continues for that SKU in those other Participating Markets.

- The Promotion will be valid for the following **markets**: Austria, Belgium, Czech Republic, Denmark, Finland, France, Germany, Hungary, Iceland, Ireland, Italy, Luxembourg, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, South Africa, Spain, Sweden, Switzerland and United Kingdom (the “**Participating Markets**”).
- The Promotion will consist of a **20% discount on selected items** explicitly marked as such on your local Nu Skin website (www.nuskin.com) (“**Promotional Products**”). This discount will be applied automatically on the Member Price (Members and Brand Affiliates) and the Retail Price (Retail Customers) of Promotional Products ordered via your local Nu Skin website, as well as through My Site, and the Vera and Stela apps. The Promotion will not be available for orders placed via NLXX.
- For Brand Affiliates, the Sharing Bonus, Sales Volume (SV) and Commissionable Sales Value (CSV) of the Promotional Products will be reduced accordingly during the Promotion.
- The Promotion cannot be combined with or applied to any other sales, promotions, discounts, codes, coupons and/or other promotional offers. The Promotion and discount will **not apply to any Promotional Products added to Automatic Delivery Rewards (“ADR”) orders or to purchases made with ADR Product Points**.
- Standard payment methods will be available for all Participating Markets except for Czech Republic, Slovakia and Poland, where the wire payment option will be removed for all orders placed during the first 3 hours of each wave of the Promotion. Note that your order will only be processed once full payment is received.
- During the Promotion **no shipping costs** will be charged in respect of standard shipments and shipments to pick up points (excluding express shipments) with a total order value **higher than €179.00 (or its local currency equivalent)**, VAT inclusive.



The amount of EUR 179, including VAT, is converted into local currency as follows (based on the currency exchange rate of 01/04/2023 as retrieved on <https://www.xe.com/fr/>):
